Dr. Conrad C. Crane is Chief of Historical Services for the Army Heritage and Education Center at Carlisle Barracks. He holds a B.S. from the U.S. Military Academy, an M.A. and Ph.D. from Stanford University, and is a graduate of the U.S. Army Command and General Staff College and the U.S. Army War College. Dr. Crane has served with the Strategic Studies Institute at the U.S. Army War College, where he held the General Douglas MacArthur Chair of Research, and has served as Director of the U.S. Army Military History Institute. Dr. Crane has written and edited many books and monographs on the Civil War, World Wars I and II, the Korean War, and the Vietnam War, including American Airpower Strategy in World War II: Bombs, Cities, Civilians, and Oil (University Press of Kansas, 2016), Cassandra in Oz: Counterinsurgency and Future War (Naval Institute Press, 2016), American Airpower Strategy in Korea, 1950-1953 (University Press of Kansas, 2000), and has written and lectured widely on air and land power issues. Dr. Crane also co-authored a prewar study on reconstructing Iraq that influenced Army planners in the Iraq War. In 2016, Dr. Crane received the Society for Military History's Samuel Eliot Morison Prize in recognition for his lifetime contributions to the field of military history.

Dr. Peter J. Dean is Professor and Pro Vice-Chancellor (Education) at the University of Western Australia. He is also a Senior Fellow at the Perth USAsia Centre. Dr. Dean completed an honours degree and Graduate Diploma of Education at the University of Newcastle, and earned a Ph.D. in Military Studies at the University of New South Wales. He has an extensive background in education and leadership that includes work at the Australian National University, where he was Senior Fellow, Strategic and Defence Studies Centre; Associate Dean Education; Associate Dean Students; and Director of Studies. He has also been on the faculty of the University of Notre Dame Australia, and worked with the NSW (New South Wales) Department of Education and NSW professional teachers associations. He has written MacArthur's Coalition: US and Australian Military Operations in the Southwest Pacific Area 1942-45 (University Press of Kansas, 2018), and The Architect of Victory: The Military Career of Lieutenant-General Sir Frank Horton Berryman, 1894-1981 (Cambridge University Press, 2011). He has edited a trilogy on Australia's experience in the Pacific War that was published by the Cambridge University Press: Australia 1942: In the Shadow of War (2013), Australia 1943: The Liberation of New Guinea (2014), and Australia 1944-1945: Victory in the Pacific (2016).

He has also co-edited, with Stephan Fruehling and Brendan Taylor, *Australia's American Alliance* (Melbourne University Press, 2016), and *Australia's Defence: Towards a New Era?* (Melbourne University Press, 2014). Dr. Dean has also written numerous public policy monographs, policy papers, book chapters and articles.

Dr. Sakaguchi Daisaku (Colonel [Ret.], JGSDF) has been a Professor at the National Defense Academy (NDA) since 2011. Graduating from the NDA, he served as an officer in the JGSDF Central Intelligence Service Unit, the Ground Staff College, and the Ground Staff Office, among others. He has also been a Research Fellow at NIDS. From 2003 to 2005, he pursued postgraduate studies at the University of Pittsburgh. In the meantime, he was the Stimson Center's Visiting Fellow during July and August 2004. He received a Ph.D. in international politics from Aoyama Gakuin University in Tokyo. Dr. David J. Kilcullen is CEO and President of the consulting firm Cordillera Applications Group. He served 25 years as an army officer, diplomat and policy advisor for the Australian and United States governments. In addition to serving in the field in Afghanistan, Pakistan, Iraq, Southeast Asia and the Horn of Africa, he was engaged in developing strategic documents such as Australia's national counterterrorism strategy in 2004, the 2006 Quadrennial Defense Review, the U.S. Government Counterinsurgency Handbook, and the Australian Army's future land operational concept, Complex Warfighting. He was also Special Advisor for Counterinsurgency to U.S. Secretary of State Condoleezza Rice in 2008. He holds a Ph.D. from the University of New South

Wales, focusing on the political anthropology of guerrilla warfare in Indonesia and East Timor. He teaches at higher educational institutions in the United States and internationally, and has published numerous scholarly papers, academic monographs and book chapters, including *The Accidental Guerrilla: Fighting Small Wars in the Midst of a Big One and Counterinsurgency* (Oxford University Press, 2009), *Out of the Mountains: The Coming Age of the Urban Guerrilla* (Oxford University Press, 2013), and *Blood Year: The Unravelling of Western Counterterrorism* (Oxford University Press, 2016).

Mr. Keir Giles is a Senior Consulting Fellow with the Russia and Eurasia Program of the Royal Institute of International Affairs (Chatham House). He is also a director of the Conflict Studies Research Centre, a group of subject matter experts in Eurasian security based in Cambridge. After graduating from UCL School of Slavonic and East European Studies (SSEES), he worked with the BBC Monitoring Service (BBCM), collecting and analyzing open source information from Russia for the government of the UK and other customers. His research focuses on Russian foreign and domestic security policy and military transformation in Russia. His recent work includes *Russia's 'New' Tools for Confronting the West: Continuity and Innovation in Moscow's Exercise of Power* (Chatham House, 2016) and *A Russian View on Landpower* (U.S. Army War College, 2015). He also has expertise in unconventional warfare including information operations and is the author of *Prospects for the Rule of Law in Cyberspace* (U.S. Army War College, 2017) and *Russia's Hybrid Warfare: A Success in Propaganda* (Bundesakademie für Sicherheitspolitik, 2015).
