**Leonard C. Sebastian** is Associate Professor and Coordinator of the Indonesia Programme at the S. Rajaratnam School of International Studies (RSIS). He is author of *Realpolitik Ideology: Indonesia's Use of Military Force* (Singapore: Institute of Southeast Asian Studies, 2006) and articles he has refereed have been published in *the Journal of Strategic Studies*, *Defense & Security Analysis*, *the Cambridge Review of International Affairs*, *South East Asia Research*, *Soccer & Society*, *Southeast Asian Affairs*, and *Contemporary Southeast Asia*; and he is a contributor to *International Relations in Southeast Asia: The Struggle for Autonomy* (Rowman & Littlefield, 2005). He is a member of the Advisory Panel to the Government Parliamentary Committee on Defence and Foreign Affairs (GPC-DFA). Dr. Sebastian joined RSIS, then called the Institute of Defence and Strategic Studies, as a Senior Fellow in October 2000. From February 1995 to September 2000, he was a Fellow at the Institute of Southeast Asian Studies (ISEAS). He received his Ph.D. from the Australian National University in 1997, where he was affiliated to the Strategic and Defence Studies Centre of the Research School of Pacific and Asian Studies. In October 2003, Dr. Sebastian was awarded a research grant from the United States Institute of Peace (USIP) after an open international competition to study militant Islamic movements in Indonesia. His research produced a report titled "Contesting Islam in Indonesia: A Contextual Study of Muslim Militancy." In April 2005, he was a Freeman Fellow participating in an Asia Foundation study tour of the United States for emerging Southeast Asian leaders. He was awarded the Fulbright-Singapore Research Award, and was a Visiting Fulbright Scholar at the Weatherhead Center for International Affairs at Harvard University from September to December 2005. From 13-18 August 2008, Dr. Sebastian participated in the inaugural Program of the Presidential Friends of Indonesia hosted by the Department of Foreign Affairs of the Republic of Indonesia. From 2008-2010, he served as consultant to Indonesia's Ministry of Defence advising on the establishment of the Indonesian Defence University (Universitas Pertahanan). Assoc Prof. Sebastian also serves as Honorary Advisor to the Board of the Ancora Foundation and the Bakrie Center Foundation in Jakarta, Indonesia. Through his association with these two institutions, he has raised over \$3.7 million worth of donations for RSIS. In January 2011, as consultant to the Asia Foundation, he served as International Policy Advisor to the Timor-Leste Ministry of Foreign Affairs and Cooperation (Ministério dos Negócios

Estrangeiros-Timor-Leste) and assisted the Ministry in organizing its first ASEAN meeting. He lectures regularly at various government and security agencies, both in Singapore and abroad.

**Nick Bisley** is Professor of International Relations at La Trobe University, Australia where he has just been appointed as Executive Director of La Trobe Asia. Until this appointment he was the Chair of the Department of Politics, Philosophy and Legal Studies. He is also the Editor in Chief of *the Australian Journal of International Affairs*, Australia's oldest and most prestigious journal in the field of International Relations. Nick has been a Senior Research Associate of the International Institute of Strategic Studies and a Visiting Fellow at the East-West Center in Washington D.C. His research and teaching expertise is in the international relations of the Asia-Pacific, globalization, and the diplomacy of great powers. Among the journals in which Nick's work has been published are *Survival*, *International Relations of the Asia Pacific*, *Journal of Contemporary China*, *Asian Survey*, and *Review of International Studies*. His most recent books are *Issues in 21st Century World Politics* 2nd edition, co-edited with Mark Beeson (Palgrave, 2013); and *Great Powers in the Changing International Order* (Lynne Rienner, 2012).

**Mingjiang Li** is an Associate Professor at S. Rajaratnam School of International Studies (RSIS), Nanyang Technological University, Singapore. He is also the Coordinator of the China Program and the Coordinator of the MSc. in Asian Studies Program at RSIS. He received his Ph.D. in Political Science from Boston University. His main research interests include China's diplomatic history, Sino-U.S. relations, Asia-Pacific security, and domestic sources of China's foreign policy. He is the author (including editor and co-editor) of nine books. His recent books are *Mao's China and the Sino-Soviet Split* (Routledge, 2012); and *Soft Power: China's Emerging Strategy in International Politics* (Lexington-Rowman & Littlefield, 2009). He has published papers in various peer-reviewed journals, including *Global Governance*, *Cold War History*, *Journal of Contemporary China*, *the Chinese Journal of International Politics*, *China: An International Journal*, *China Security*, *Security Challenges*, and *the International Spectator*.

**Jagannath P. Panda** is Research Fellow and Centre Head (East Asia) at the Institute for Defence Studies and Analyses (IDSA), New Delhi. Dr. Panda is also the Research

Director (India office) at the Institute for Transnational Studies (ITS), Germany and Italy. Dr. Panda's research interests are: Sino-Indian relations, BRICS & Emerging Powers, China's foreign policy, Asia's Multilateralism, among others. He has been a member of IDSA delegation for TRACK-II dialogues with various Chinese, Japanese, and South Korean think-tanks and institutes. He has also published in peer-reviewed journals like *Strategic Analyses* (Routledge), *China Report* (Sage), *Journal of Contemporary China* (Routledge), *Asian Perspective* (Lynne Rienner), *Portuguese Journal of International Affairs* (Europress), *China and Eurasia Forum Quarterly* (Central Asia- Caucasus Institute & Silk Road Studies), *Indian Foreign Affairs Journal* (MD Publications Pvt Ltd), and more. Prior to joining IDSA, Dr. Panda worked as Centrally Administered Fellow at the ICSSR, Ministry of HRD, Govt. of India, New Delhi.

**Tomotaka Shoji** is a senior fellow of the National Institute for Defense Studies (NIDS), Japan. He specializes in politics and security in Southeast Asia (especially Indochina), and relations between Southeast Asia and Japan. He received his B.A., M.A. and Ph.D. in international relations from the University of Tokyo. He also received his M.Sc. (Strategic Studies) from the S. Rajaratnam School of International Studies (RSIS, Singapore). Dr. Shoji's publications include "ASEAN Security Community: An Initiative for Peace and Stability" (*NIDS Security Reports*, No. 4, December 2008), "Pursuing a Multi-dimensional Relationship: Rising China and Japan's Southeast Asia Policy" (Jun Tsunekawa ed., *The Rise of China: Responses from Southeast Asia and Japan*, NIDS, 2010), "Japan's Security Outlook: Security Challenges and the New National Defense Program Guidelines" (Eiichi Katahara ed., *Security Outlook of the Asia-Pacific Countries and Its Implications for the Defense Sector*, NIDS, 2011), and "Vietnam, ASEAN, and the South China Sea: Unity or Diverseness?" (*NIDS Journal of Defense and Security*, No. 13, December 2012). He is also the author of the chapter on Southeast Asia of *NIDS East Asian Strategic Review* in 2011-2013.

**Kim Tae-Hyo** is, at present, Professor of Political Science at SungKyunKwan University, Vice-President and Director for International Cooperation at the New Asia Research Institute, Editor of the New Asia Journal, Steering Committee Member of CSCAP Korea, and Guest Editorial Writer at Dong-A Daily Newspaper. Dr. Kim's research focus centers on security strategy and security relations in Northeast

Asia. His recent books include *Foreign Policy in the 21st Century* (Myung-in Books, 2012), and *the Future of U.S.-Korea-Japan Relations: Balancing Values and Interests* (CSIS Press, 2004), and he has published about 70 papers in security-related journals. He was formerly Senior Secretary to the President for National Security (2012), Deputy National Security Advisor (2008-2011), Professor at the Institute of Foreign Affairs and National Security (2002-2005), Visiting Professor at Keio University (2001), Researcher at the Academy of Korean Studies (2000). Educated at Sogang University (B.A., 1990), Cornell University (M.A., 1993), and the University of Chicago (Ph.D., 1997). Awarded the Nakasone Peace Prize (2009) and a medal for distinguished service in the government (2012).

**Dmitri Trenin** is Director of the Carnegie Moscow Center since 2008, and a Senior Associate of the Carnegie Endowment for International Peace since 2003. Before joining Carnegie in 1994, he served in the Soviet and Russian army. Col. Trenin's postings included Iraq (with the military assistance group, 1975-76), Germany (liaison with the Western powers in Berlin, 1978-83), and Switzerland (INF and START talks, 1985-91). For several years, Trenin taught area studies at the Defense University in Moscow from which he graduated in 1977. He was also a senior fellow at NATO Defense College (1993) and, upon retirement from the military, a visiting professor at the Vrije Universiteit Brussel (1993-1994). From 1994-1997, Trenin was also a senior research fellow at the Institute of Europe, Russian Academy of Sciences. At Carnegie, Dmitri Trenin chairs the Foreign and Security Policy Program. He is the author of several books, including *Unconditional Peace: 21st Century Euro-Atlantic as a Security Community* (2013); *Post-Imperium: A Eurasian Story* (2011; Russian and Japanese editions, 2012); *Solo Voyage* (essays on Russia's foreign policy, 2009); *Getting Russia Right* (2007); *Central Asia. The Views from Washington, Moscow and Beijing* (2007, co-authored); *Integration and Identity. Russia as a New West* (2006); *Gestrandete Weltmacht* (in German, 2005); *Russia's Restless Frontier. The Chechnya Factor in Post-Soviet Russia* (co-authored, 2004); *The End of Eurasia: Russia on the Border Between Geopolitics and Globalization* (two printings, 2002 and 2001); *A Strategy for Stable Peace. Toward a Euro-Atlantic Security Community* (co-authored, 2002); *Russia's China Problem* (1998); and *Baltic Chance: The Baltic States, Russia and the West in the Emerging Greater Europe* (1997). Among the books Trenin has edited are *The Russian Military: Power and Policy* (2004), *Ambivalent Neighbors: The NATO and EU Enlargement and the Price of Membership* (2003); *Russia and*

*the Main Security Institutions in Europe: Entering the 21st Century* (2000); *Kosovo: International Aspects* (1999); *Commonwealth and Security in Eurasia* (1998). Trenin is a member of the International Institute for Strategic Studies in London, the Russian International Affairs Council, and the Royal Swedish Academy of Military Science. He serves on the International Advisory Board of the Finnish Institute for International Affairs, and is a member of the Board of Trustees of the Moscow School of Civic Education. A frequent commentator for world news media, from *the New York Times* to *the Moscow Times* to Beijing's *Global Times*, he serves on the editorial boards of *the Washington Quarterly*, *International Politics*, *Pro et Contra*, *Insight Turkey*, and *Baltic Course*.

*Satu Limaye* was named Director of the East-West Center in Washington in February 2007. He is also a Senior Advisor at the Center for Naval Analyses Corporation (CNAC). He is the creator of the Asia Matters for America initiative, an interactive resource for credible, non-partisan information, graphics, analysis and news on US-Asia Pacific relations and the national, state and local levels, Founding Editor of the Asia-Pacific Bulletin series, an editor of the journal *Global Asia*, and sits on the international advisory council of the journal *Contemporary Southeast Asia*. Dr. Limaye publishes and speaks on U.S.-Asia relations and is a reviewer for numerous publications, foundations, and fellowship programs. From October 2005 to February 2007, he was a Research Staff Member of the Strategy and Resources Division at the Institute for Defense Analyses (IDA); and from July 1998 to October 2005, Director of Research and Publications at the Asia-Pacific Center for Security Studies (APCSS), a direct reporting unit of U.S. Pacific Command. He has been an Abe Fellow at the National Endowment for Democracy, and a Henry Luce Scholar and Research Fellow at the Japan Institute of International Affairs (JIJA) in Tokyo. He is a magna cum laude and Phi Beta Kappa graduate of Georgetown University, and received his doctorate from Oxford University (Magdalen College) where he was a George C. Marshall Scholar.
